#### **Financial Report**

Some documents provided do not include current balance; information is a few days old. Womble says Bancorp had city property appraised for loan discussed at the March 6 special meeting. Bancorp will not finance the property with the sewer building included; they request a survey excluding the sewer building and will refinance the rest of the property without that building.

# **State of the City Report**

Mayor Baker says priorities are bringing in tax revenue and using it as best we can.

Plans for the TA truck stop are moving forward. TA has accepted the plan and some of the architectural work has already been completed. Construction may begin this summer.

#### **Old Business**

Womble is focusing on getting the IRS paid; thousands of dollars of penalties continue to accrue. City has paid over \$50,000 so far. IRS sees effort so has not begun calling regularly.

#### **New Business**

Womble reports insurance has lapsed on City Hall and city vehicles; city doesn't have money to pay Arkansas Municipal League for insurance, and there's no money in other funds to pull. City owes about \$10,000 in past-due insurance.

Mayor Baker says police cars must be pulled off the road to prevent liability for the city.

Womble calls bookkeeper Joyce Akrum at home. Joyce reports the bank holding the loan for the two police Tahoes has added insurance to those loans, so those are covered. The coverage is not as good as what ARML provides. ARML was not paid for all of 2023 and part of 2022.

Baker reiterates that other vehicles besides the two Tahoes must be pulled from road until insurance is paid. He will meet with Joyce Thursday to examine options.
