**Call to order**

Council member Brenda Womble called the meeting to order at 6:04 p.m.

**Pledge of Allegiance and Invocation**

Womble led the Pledge of Allegiance and gave the invocation.

**Departmental Reports**

*Financial statement:*

The financial report was a handwritten document. Womble says it will be in this or a spreadsheet format through the end of the year, with approval of legislative audit. Baker asks if QuickBooks is providing any support since we are still paying for them (pending getting all records switched to the new vendor). Womble says we are trying to get that payment stopped, because we are not getting any use from QuickBooks.

*Police Department:* Morales presented a written report and said he has hired Chris Medlin as a part-time detective to investigate as needed. The department will be fully staffed again in November when two or three officers start work.

*Planning Commission:* no report

*Street Department:* Several potholes need repair, including on Elaine, Nix, Needles and Babcock, where Malvern cut the pavement to repair a water line but has not repacked or

repaved the street. We will get bags of cold-mix asphalt to repair these places. Discussion of other streets needing repair (Division, Cuffman Mill, Oak Meadow, Pleasant Hill, JJ Hughes, Jenny Lane, etc.), but no action now. Baker says we need to do something about dirt roads, too. She is going to call the state highway department to check on their plans for specs, planning, etc. Hughes will contact Scott to schedule a day to repair the asphalt.

*Sewer Department:* no report

*Secretary*

Womble says we need to hire a new secretary to learn sewer, Darlene's job, and all other aspects before Darlene retires. She has received a resume from a candidate willing to work for minimum wage, for now. Shuffield emphasizes need to check references. Morales says he can run a background check on the applicant.

*Budget*

Hughes introduces Resolution 2025-2, the 2026 budget, for future consideration. All council members will review the budget to make necessary changes before adopting it in December.

*Sewer hookup*

After discussion, the council instructed Womble to call city attorney Greg Vardaman for advice regarding a sewer hookup for Carthel Clark. She will report to the council afterward.
